

## SAMSUNG 2025 SLIDE-IN READY2FIT™ GUARANTEE TERMS AND CONDITIONS

**Offer description.** Samsung guarantees that your new 30” Samsung Front Control Slide-in Range will fit the existing 30” wide cutout and countertop that houses your existing 30” Freestanding Range of the same width and configuration, or Samsung will give you up to \$100 based on the product purchased (awarded as a Samsung Prepaid Mastercard®) to cover the cost of professionally modifying the countertop cut-out (“Offer”).

Your payment will be delivered via email with instructions for claiming your Prepaid Mastercard. Please note that access to your payment expires 3 months from the date it is issued. Your right to the payment expires after that time. You must claim your card within that timeframe. Use your card everywhere Mastercard is accepted in the U.S. Issued by The Bancorp Bank, Member FDIC, pursuant to license by Mastercard International Incorporated. Mastercard is a registered trademark, and the circles design is a trademark of Mastercard International Incorporated. Your use of the prepaid card is governed by the Cardholder Agreement, and some fees may apply. This is not a gift card. Please note that prepaid cards are subject to expiration, so pay close attention to the expiration date of the card.

Offer valid on select Samsung Front Control Slide-in models (each a “Qualifying Product”). Consult the list below to determine if your model is eligible. Offer limited to one (1) claim per household. Offer cannot be combined with other offers, promotions, or discounts.

**Offer timing.** Qualifying Product must be purchased between January 1, 2025 and December 31, 2025. Offer claim forms, including all required information and documentation must be submitted as set forth below within 90 days of promotion end date.

**Offer eligibility.** The Offer is open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least 18 years old at the time of purchase. **Size and configuration requirements.** Offer applies to 30” Front Control Slide-ins only. Offer valid only when replaced Freestanding Range is 30” wide and same fuel type as the new Slide-in Range. For example, a new Front Control Slide-in Range replacing an existing 36” or 24” Freestanding Range will not qualify for the Offer. Similarly, a new gas Front Control Slide-in Range replacing an existing electric Freestanding Range will not qualify for the Offer.

**Residential and consumer use only.** Offer valid on replacements of existing Freestanding Ranges in residential households only; not valid on new construction, first-time Range installations, or remodeling projects. Offer not valid on bulk purchases or purchases by wholesalers, contractors, builders, or multi-unit apartment or condominium owners.

**Professional modification required.** Offer valid only when modifications to the countertop cut-out are performed by a professional contractor or carpenter; modifications performed by you or other non-professionals are not eligible. **Offer does not apply to installation or other costs.** Offer limited to \$100 (inclusive of any applicable taxes) or the cost of professional modification, whichever

is lesser. You are responsible for the excess of any professional modification costs exceeding \$100. When using a professional contractor or carpenter to perform the modification work, you must obtain a receipt or invoice that includes the name of the person or entity performing the work, the date the work was performed, and a detailed description of the work performed. Modification and installation costs cannot be combined; the receipt or invoice must show separate line items for modification costs and installation costs (if applicable).

**Photographic proof required.** You must submit before and after photographs of your old 30” Freestanding Range and Qualifying Product. Both photographs must show the Range installed in the wall or countertop, and both must include proof of dimensions. For example, you can hold a yard stick horizontally against the Range in order to demonstrate that both are 30”.

**No warranty of workmanship.** Samsung is not responsible for and makes no representations or warranties regarding the workmanship of the cabinet or countertop cut-out modifications performed by your professional contractor or carpenter. It is your responsibility to ensure that you obtain adequate warranties and other assurances from your professional contractor or carpenter regarding the quality and workmanship of the modifications to your countertop cut-out.

### How to Redeem This Offer

2. Take a photo and record the model and serial numbers of the existing Range and the Qualifying Product. Make sure you photograph your old Range (step 3) before uninstalling it to obtain the serial number.
3. Photograph and print before and after shots of the existing Range and the newly installed Qualifying Product. Both photographs must show the existing and new Range installed, and both must show proof of dimension. For example, you can hold a measuring tape horizontally against the Ranges in order to demonstrate that both are 30" wide.
4. Utilize a professional contractor or carpenter to perform any needed modifications to your existing countertop cut-out, and get a receipt or invoice that includes the following information: (a) date of work performed; (b) name of person or entity performing work; (c) detailed description of work performed; and (d) separate line items for modification and installation costs, if applicable.
5. Visit [www.samsung.com/us/shop/promotions](http://www.samsung.com/us/shop/promotions) and select the appropriate promotion to complete a claim form and submit all other required documentation described within 90 days of promotion end date.
6. Required documentation includes:
  - a. Copy of your sales receipt showing the purchase of the Qualifying Product between January 1, 2025 and December 31, 2025.
  - b. Copy of your sales receipt that include the model number and serial number.
  - c. Proof of your delivery date.
  - d. Before and after photographs showing accurate dimensions.
  - e. Copy of receipt or invoice showing your professional modification costs.
  - f. Model and serial numbers of the existing Freestanding Range and Qualifying Product.
