

TERMS AND CONDITIONS FOR SAMSUNG MONITOR OFFER

Offer begins 12:00 AM Eastern Time ("ET") February 23, 2026 and ends 11:59 PM ET August 23, 2026 or when supplies are exhausted, whichever is sooner ("Offer Period"). Open only to legal residents of the 50 US & DC who (i) are 18 years of age or older (and have at least reached the age of majority in their state of residence) and (ii) make a qualifying purchase (as described below).
