

SAMSUNG® SOLVE FOR TOMORROW EDUCATOR REFERRAL SWEEPSTAKES

Official Rules

The Sweepstakes will consist of one (1) drawing to award one (1) prize ("**Prize**"). A random drawing will be conducted by the Administrator on or about Wednesday, October 30, 2024 from all eligible entries received during the Sweepstakes Referral Period to select one (1) winner ("**Winner**").

Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes.
